Any person with a bachelor's degree who has not been formally admitted to a graduate degree program, but wishes to enroll in graduate course work for a semester, summer session, workshop, or seminar institute, may apply to be a Special (that is, non-degree-seeking) Student by completing this form and returning it to an OSU Graduate Admissions office along with official transcripts. No entrance examinations or letters of recommendation are required. Graduate Special students are subject to the same academic requirements as degree-seeking students.

TOEFL Score: Applicants for whom English is a second language are required to demonstrate an acceptable level of spoken English usually by submitting a TOEFL or IELTS score. A TOEFL score of at least 79 (internet based test), 213 (computer based test) or 550 (paper based test) is required regardless of the number of semesters or terms completed in other institutions of higher education, including OSU, or prior enrollment in English language programs. Alternatively, an official IELTS, academic stream, examination with a minimum overall band score of 6.5 will satisfy the English proficiency requirements for admission to a graduate program. Note that an applicant who has or will have completed a baccalaureate or graduate degree from a college or university where English is the primary teaching language, and which is located in a country where English is a primary language, is **not** required to submit a TOEFL or IELTS score.

Domestic Students and Permanent Residents: A non-refundable application fee of \$15.00 is required. This can be paid either by check or money order payable to "Oklahoma State University." Applications cannot be processed until this fee is received. Return this application to one of the OSU Graduate Admissions office listed above. If you are a Permanent Resident of the United States, you must provide a copy of both sides of your Permanent Resident Card with this application form. International Students: A \$75.00 non-refundable Application Fee, either by check or money order payable to "Oklahoma State University" is required. F-1 and J-1 visa holders must be in full-time, degree seeking programs and may not enroll as Special students unless associated with an OPT or OCT opportunity.
