Suggested: Exchange Bank – We can open an account without a deposit; however, our group will need to obtain a Tax ID in order to do so.

This is not currently allowed by our constitution, Article VIII Section 3: "The funds of the Graduate Society, if any, will be deposited with the University banking services and these may be audited yearly, preferably at the time a new treasurer is installed"
